### **Call to Order and Roll Call**

Chair Curry called the meeting to order at 4:10. The roll was called and a quorum was present. Chair Curry modified the agenda, removing items IV (Discussion of Reappointment of Dr. April Massey) and V (Discussion of Intellectual Property Statement) from the agenda. Testimony from several individuals was added after VI (c) Various Accreditations.

## **Approval of Minutes**

The August 28, 2013 minutes were reviewed by the committee and unanimously approved.

Discussion Concerning Proposed Criteria and Guidelines for Academic "Minors" and "Concentrations" Dr. Petty reported the language pertaining to the criteria and guidelines for approving minors and concentrations will be finalized and sent to the Faculty Senate. Committee members will be provided with the criteria and guidelines for consideration at the next Academic Affairs Committee meeting.

### Master of Arts in Adult Education Program – Discussion and Resolution

Dr. Petty presented the proposal for the Master of Arts in Adult Education. The program has been through the academic review process and approved by the Faculty Senate in early November. The committee approved moving the program forward to the full Board for consideration, pending a Fiscal Impact Statement (FIS). A copy of the FIS will be sent to the committee members.

## **Update on Other Academic Matters**

Vision 2020 Strategic Plan. Dr. Petty discussed:

- seventeen programs approved for termination (pending the Board signed resolution), and the work being done on the teach out process for these programs;
- working with the National Education Association (NEA) representative concerning a potential reduction-in-force; and
- initiatives concerning online learning and faculty professional development.

Current Academic Year. Dr. Petty reported classes start on Monday, January 13. Current enrollment numbers were discussed (community college – 2,205; flagship – 1,585).

*Various Accreditations.* On January 6, approximately 275 members of the university community participated in a four hour session regarding the Middle States accreditation. Dr. Marilyn Hamilton and Dr. Lena Walton are the co-chairs. There will be three additional sessions (governance, assessment, and budget and planning).

The initial site visit for the architecture program was held November 1 - 6, 2013. The Mortuary Science program's probation status was removed November 5. Speech pathology, which was on probation, has been granted an eight-year accreditation to 2021.
