WHEREAS, pursuant to 8B DCMR §1462, Dr. Yu's records document his effectiveness, contribution, and continuing growth as a teacher and mentor (of students and of faculty colleagues); his substantial and continuing contribution to research and scholarship; his leadership of the strategic initiative in Cloud Computing; and his strong record of service to the University, and the profession, and as his work has been widely perceived as outstanding, providing evidence of extraordinary potential for and commitment to continued growth, productivity, and service; and

WHEREAS, Professor Yu has demonstrated exemplary leadership in securing successful accreditation from the Accreditation Board for Engineering and Technology (ABET) for the Computer Science undergraduate program, and he was instrumental in setting up the National Security Administration-approved Center of Excellence in Cybersecurity.; and,

WHEREAS, pursuant to 8B DCMR §1470, the Dean, the Provost and the President have affirmed the recommendation of tenure for Professor Yu and the President has forwarded the recommendation for tenure to the Board of Trustees:

Tenure Approval for Professor Dr. Byunggu Yu

The proposed resolution is for the approval of tenure for Professor Dr. Byunggu Yu. It has been noted in the Board Resolution that Professor Yu's achievements have been outstanding in teaching, research, service, and leadership. The national average salary for a Professor in Computer Science is approximately \$111,000 and the recommended salary for Professor Yu is \$98,759. Dr. Yu's promotion was approved by the Provost and President in the fall of 2012 with an effective date of October 1, 2012. Based on his FY2012 salary of \$85,074, this position will cost the University \$17,400 in salary and benefits. His position has been budgeted as a non union faculty position. There is no monetary impact because funding was already identified in FY14.

The Executive Management within the Budget Department of the Office of the Chief Financial Officer of UDC has approved this request based on the information provided. We do not anticipate any risks.

Dr. Byunggu Yu, Associate Professor and Chairperson of the Computer Science and Information Technology Department, applied this past summer for promotion to full professor and for tenure. He has been at the University since 2007 (completing his fifth year) and has established a distinguished record in teaching, research, and service, as documented in the attached dossier. His application for tenure and promotion to Professor has been reviewed and strongly recommended by a special tenure and promotion panel appointed by Beverly Hartline, in her capacity as Acting Dean of SEAS. The panel consisted of three tenured UDC professors in SEAS and one tenured professor of computer science at the George Washington University. The panel strongly recommended to Dean Hartline that Dr. Yu is well qualified for tenure and for promotion to full professor. Dr. Hartline reviewed the dossier and panel recommendations, and she delivered those materials and her evaluation to me with her strongest support.

Dr. Yu's file documents his effectiveness, contribution, and continuing growth as a teacher and mentor (of students and of faculty colleagues); his substantial and continuing contribution to research and scholarship; his leadership of the strategic initiative in cloud computing; and his strong record of service to the University, and the profession. His work has been widely perceived as outstanding, providing evidence of extraordinary potential for and commitment to continued growth, productivity, and service.

I have reviewed the materials and evidence and concur with the recommendation of both the panel and Dr. Hartline that Dr. Yu is qualified for promotion to professor with tenure at the University of the District of Columbia.
