## BOARD OF TRUSTEES UNIVERSITY OF THE DISTRICT OF COLUMBIA UDC RESOLUTION NO. 2009-21

**SUBJECT:** AMENDMENTS TO FEE STRUCTURE – FINAL RULEMAKING

WHEREAS, District of Columbia law (D.C. Official Code §38-1202.06(8)) provides for the Board of Trustees of the University of the District of Columbia to fix tuition, and fees in addition to tuition, to be paid by resident and nonresident students attending the University; provided, that such tuition and fees are adopted by the Trustees in accordance with the provisions of D.C. Official Code §2-505(a); and

WHEREAS, the Board of Trustees has promulgated a substantially revised schedule of tuition and fees for students at its four-year and community college components; and

WHEREAS, two (2) of the fees, the Student Health Insurance fee and the Tuition Management System fee, are not subject to the control of the Board of Trustees, but are instead set by external providers; and

**WHEREAS**, because the two (2) above-referenced fees are not subject to the control of the Board of Trustees, it is not appropriate to include them on a fixed-cost basis as part of the University System fee schedule; and

**WHEREAS,** the rules contained in the attached Notice of Final Rulemaking were published under a Notice of Proposed Rulemaking for a thirty-day comment period on April 17, 2009, 56 D.C.Reg. 2978; and

**WHEREAS,** no comments were received in response to the Notice of Proposed Rulemaking;

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Trustees of the University of the District of Columbia hereby adopts the attached Notice of Final Rulemaking amending the tuition and fee schedule to indicate that the student health insurance and Tuition Management System fees are variable; and

**BE IT FURTHER RESOLVED** the General Counsel is hereby directed to publish the Notice of Final Rulemaking in the District of Columbia Register as soon as is practicable, in accordance with the provisions of D.C. Official Code § 2-505(a).

## **NOTICE OF FINAL RULEMAKING**

The Board of Trustees of the University of the District of Columbia pursuant to the authority set forth under §201(a) of the District of Columbia Public Postsecondary Education Reorganization Act Amendments ("Act") effective January 2, 1976 (D.C. Law 1-36; D.C. Official Code § 38-1202.01), and D.C. Official Code § 38-1202.06, hereby amends Section 728 of Chapter 7 of Title 8, DCMR entitled "Tuition and Fees," effective upon publication of this notice in the <u>D.C.</u> Register. The purpose of the rule is to amend two (2) fees, the student health insurance fee and the Tuition Management System fee. These two (2) fees are not subject to the University's control and accordingly are not appropriate to be listed on a fixed-cost basis in the tuition and fee schedule.

The Board of Trustees of the University of the District of Columbia hereby amends Section 728 of the Title 8, DCMR, as follows:

## Section 728.4

Amend § 728.4(q) (Student Health Insurance) by striking "\$175.00" and inserting in its place "Varies.".

Amend § 728.4(t) (Tuition Management System) by striking "\$30.00" and inserting in its place "Varies.".
